The meeting was called to order at 6:30 p.m. by Mayor Clark Shultz, followed by the pledge of allegiance.

PUBLIC INPUT:

There was no public input.

AMENDMENTS TO THE AGENDA:

There were no amendments to the agenda.

MAYOR'S REPORT:

Wichita State University founded one of the earliest honors programs in the country in 1957, naming the program in honor of Dr. Emory Lindquist in 1978. Mayor Shultz introduced Betany College Interim President Steve Eckman who spoke briefly about Emory Lindquist. Mayor Shultz proclaimed August 24, 2024, as a day of celebration honoring Emory Lindquist Honors Program and the Dorothy and Bill Cohen Honors College.

CONSENT AGENDA

Councilmember Kirsten Bruce moved to approve the minutes from the August 5, 2024, regular Council meeting, Payroll Ordinance 5497, and Purchase Order Ordinance 5498. Motion seconded by Councilmember Andrew Smith and passed 6-0 by roll call vote.

NEW BUSINESS:

School Resource Officer (SRO) Agreement

At the City Council meeting on July 15, 2019, the Lindsborg City Council unanimously approved an initial five-year contract with the USD 400 School District to establish and support a School Resource Officer (SRO) position.

Following discussions with the USD 400 Superintendent and staff, both parties concur that extending the SRO position through a new five-year contract would be advantageous. The USD 400 School Board approved the renewal of this contract at their meeting in July 2024.

There were some minor changes between the old and new contracts. Below is a summary of those changes:

- Legal terms in the agreement were revised based on the reviewing attorneys' recommendations.
- Added language to confirm both parties' agreement on SRO selection, allow the Lindsborg Police
 Department flexibility to use SROs for short-term absences or vacancies, outlines the district paying for
 overtime assignments, and specifies when the officer can return to field duties when not working for
 district.
- Added language to specify the agreement's duration and clarify expense distribution.
- Updated numbering, headings, and minor language changes and clarifications.

Councilmember Rebecca Van Der Wege moved to approve the SRO contract between the USD 400 School District and the City of Lindsborg. Seconded by John Presley and passed 6-0 by roll call vote.

ADJOURNMENT:

Councilmember Kirsten Bruce moved for adjournment, seconded by Councilmember Andrew Smith, and passed 6-0 by voice vote. The meeting was adjourned at 6:59p.m.
