

ORDINANCE NO. 5365

AN ORDINANCE DEFINING THE BOUNDARIES OF THE FOUR WARDS OF THE CITY OF LINDSBORG, KANSAS, TO CONFIRM THE INCLUSION OF STOCKHOLM ESTATES INTO WARD 1.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LINDSBORG, KANSAS:

Section I. Ward Number One (1) shall comprise all that part of the City situated North and East of a line beginning at the Southeast corner Block 7 lot 11 of Stockholm Estates Subdivision; thence West along the South lot lines of 12,13,14,15 of Block 7 of Stockholm Estates Subdivision, lots 6,5,4,3,2,1 of Block 8 of Stockholm Estates Subdivision, and lot 16 of Block 2 of Stockholm Estates Subdivision; thence North along the West lot lines of 16,15,14,13,12,11,10 of Block 2 of Stockholm Estates Subdivision, thence West along the South lot lines of lots 12,23 Block 1 of Eberhardt's Addition; thence West along Olson Street centerline to the point of intersection with the centerline of Main Street; thence South along the centerline of Main Street to the point of intersection with the centerline of Madison Street; thence West along the centerline of Madison Street to the point of intersection with the centerline of Washington Street; thence North along the centerline of Washington Street to the point of intersection with the centerline of Swenson Street; thence East along the centerline of Swenson Street to the point of intersection with the centerline of Washington Street; thence North along the centerline of Washington Street to the point of intersection with the centerline of Normal Street; thence East to the point of intersection with the West lot line extended of lot 6, Block I Rolander-Shields 2nd Addition; thence North along the West lot lines of lots 6,7,8,9,10 and I of Block I of Rolander-Shields Addition, lots 24,25,26,27,29,30,31 and I of Block I of Northridge Addition, and lots 5,6,7 and 8 of Northridge II Addition; thence North along the West lot lines of lots abutting Main Street on the West to the North line of Sheridan Street; thence East along the North line of Sheridan Street to the point of intersection with the corporation boundary of the City.

Section II. Ward Number Two (2) shall comprise all that part of the City situated West of Ward Number One and North of a line beginning at the intersection of the centerline of West Lincoln Street with the West corporation boundary of the City; thence East along the centerline of Washington Street to the centerline of Chestnut Street; thence North along the centerline of Chestnut Street to the point of intersection with the centerline of State Street; thence East along the centerline of State Street to the point of intersection with the centerline of Third Street; thence North along the centerline of Third Street to the point of intersection with the centerline of Saline Street; thence East along the centerline of Saline Street to the point of intersection with the centerline of Washington Street; thence North along the centerline of Washington Street to the point of intersection with the centerline of Madison Street, said intersection point being at the Southwest corner of the boundary of Ward One.

Section III. Ward Number Three (3) shall comprise all the part of the City situated South of Ward Number Two and West of a line beginning at the point of intersection of the centerline of Saline Street with the centerline of Washington Street, said point being at the boundary of Ward Number

Two; thence East along the centerline of Saline Street to the point of intersection with the centerline of the alley between Washington Street and Main Street; thence South along the centerline of said alley to the point of intersection with the centerline of Lincoln Street; thence East along the centerline of Lincoln Street to the centerline of Main Street; thence South along the centerline of Main Street to the point of intersection with the South corporation boundary of the City.

Section IV. Ward Number Four (4) shall comprise all that part of the City situated East and South of a line beginning at the intersection of the centerline of Main Street with the South corporation boundary of the City; thence North along the centerline of Main Street to the point of intersection with the centerline of Lincoln Street; thence West along the centerline of Lincoln Street to the point of intersection with the centerline of the alley between Main Street and Washington Street; thence North along the centerline of the said alley to the point of intersection with the centerline of Saline Street; thence West along the centerline of Saline Street to the point of intersection with the centerline of Washington Street; thence North along the centerline of Washington Street to the point of intersection of the centerline of Madison Street; thence East along the centerline of Madison Street to the point of intersection with the centerline of Main Street; thence North along the centerline of Main Street to the point of intersection with the centerline of Olson Street; thence East along the centerline of Olson Street extended to the East corporation boundary of the City.


Section V. All Ordinances in conflict herewith are hereby repealed.
