ORDINANCE NO. 5381

AN ORDINANCE INCORPORATING BY REFERENCE THE STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES, EDITION 2022, REGULATING TRAFFIC WITHIN THE CITY OF LINDSBORG.

Be it Ordained by the Governing Body of the City of Lindsborg, Kansas:

<u>Section 1</u>. That the Standard Traffic Ordinance for Kansas Cities, prepared and published by the League of Kansas Municipalities, Edition 2022, be and the same hereby is incorporated by reference, subject to Section 4 hereof, as a traffic ordinance of the City of Lindsborg, Kansas, under the provisions of K.S.A. 12-3009 through 12-3012, including any amendments thereto, and K.S.A. 12-3301 and 12-3302.

<u>Section 2</u>. That not less than three official copies of the Standard Traffic Ordinance for Kansas Cities, Edition 2022, marked or stamped "Official Copy as Adopted by Ordinance No. 5381, and to which shall be on file with the City Clerk of Lindsborg, Kansas, to be open to inspection and available to the public at all reasonable business hours.

<u>Section 3</u>. Traffic Infractions and Traffic Offenses. (a) An Ordinance traffic infraction is a violation of any section of this ordinance that prescribes or requires the same behavior as that prescribed or required by a statutory provision that is classified as a traffic infraction in K.S.A. 8-2118. (b) All traffic violations which are included within this ordinance, and which are not ordinance traffic infractions, as defined in subsection (a) of this section, shall be considered traffic offenses.

<u>Section 4.</u> The penalty for committing the offense of Inattentive Driving, in violation of Section 104 of the Standard Traffic Ordinance for Kansas Cities, as adopted from time to time, is hereby established to be a fine not to exceed \$75.00 for a first offense and a fine not to exceed \$130.00 for a second or subsequent offense.

<u>Section 5</u>. Penalty for Scheduled Fines. The fine for violation of an ordinance traffic infraction or any other traffic offense for which the municipal judge establishes a fine in a fine schedule shall not exceed \$500.00. Maximum term of incarceration is 6 months unless otherwise specified.

<u>Section 6</u>. That all ordinances of said City in conflict with any of the provisions of said Standard Traffic Ordinance for Kansas Cities are hereby repealed except that the provisions of ordinance number 3053 establishing certain speed zones within areas of the City are hereby ratified and any provisions of the Standard Traffic Ordinance, Edition 2022, in conflict with said Ordinance Number 3053 are excluded from adoption by this Ordinance.

<u>Section 7</u>. Chapter XIV, Article 1, entitled Standard Traffic Ordinance, of the Lindsborg Municipal Code is hereby amended to include the provisions of Section 1 through 5 of this Ordinance.

Section 8. All prior ordinances in conflict with the provisions herein are hereby repealed.

<u>Section 9</u>. That this ordinance shall take effect and be in force from and after its publication in the official City newspaper.
