## **ORDINANCE NO. 5382**

AN ORDINANCE REGULATING PUBLIC OFFENSES WITHIN THE CORPORATE LIMITS OF THE CITY OF LINDSBORG, KANSAS: INCORPORATING BY REFERENCE THE "UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES," EDITION OF 2022.

Be it Ordained by the Governing Body of the City of Lindsborg, Kansas:

Section 1. INCORPORATING UNIFORM PUBLIC OFFENSE CODE. There is hereby incorporated by reference, subject to Section 2 hereof, for the purpose of regulating public offenses within the corporate limits of the City of Lindsborg, Kansas, that certain code known as the "Uniform Public Offense Code", Edition 2022, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three copies of said Uniform Public Offense Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 5382 and to which shall be attached a copy of this ordinance and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours.

Section 2. The penalty for committing the offense of Throwing Objects, in violation of Section 10.16 of the Uniform Public Offense Code for Kansas Cities, as adopted from time to time, is hereby established to be a fine not less than \$60.00 nor more than \$120 if there is no resulting damage, and not less than \$120 nor more than \$240 if there is resulting damage. Restitution shall be ordered for any resulting damage.

<u>Section 3</u>. All prior ordinances in conflict with the provisions of the Uniform Public Offense Code, Edition of 2022, are hereby repealed.

<u>Section 4</u>. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.
